MINUTES

Taos Municipal School Board of Education Regular Board Meeting Tuesday, November 13, 2018 Taos Pueblo, Taos NM 87571

- **A.** Call to order-The regular meeting of the Taos Municipal Schools Board of Education was called to order by President Sanborn at 6:15 pm.
- **B.** Roll Call-Administrative Assistant, Linda Sanchez conducted a roll call. The following members were present: President James Sanborn; Vice President Mark Flores; Secretary Whitney Goler, and Member Dr. David Chavez.

Absent was: Member Jason Silva.

At this time President Sanborn invited members of the Taos Pueblo to do the Welcome Invocation. Governor Gilbert Suazo did the Invocation.

There was also a moment of silence in recognition of all Veteran's who have served in the military and who are presently serving in the military.

- **C. Pledge of Allegiance**-Superintendent Dr. Torrez, led the board members and the audience in the Pledge of Allegiance.
- **D. Approval of the Agenda**-President Sanborn made a motion to approve the agenda as presented, seconded by Member Flores. Roll Call-President Sanborn-yes; Vice President Flores-yes; Secretary Goler-yes, and Member Chavez-yes. Motion carried.
- **E. Student Report-**Aaron Martinez & Madeline Steinberg were unable to attend the board meeting, but did submit a student report to the board. President Sanborn thanked them for providing a report and read it to the audience. The student report included the following:
 - 1. Taos Interact is planning on a community project in Puerto Rico during Spring break. They will help build a community center.
 - 2. HOSA-an optional sale for HOSA, members of Taos HOSA chapter are able to buy Scrubs with a Taos logo and tiger.
 - 3. On November 12, school was cancelled due to snow.
 - 4. Prostart are in the beginning stages of planning.
 - 5. Everybody is happy because of the snow and next week is Thanksgiving Break.
 - 6. Cross Country members raced this weekend in the state meet.
 - 7. In the English classes, students are memorizing poems for Poetry Out Loud.

F. Presentations

a) Taos Pueblo Dignitaries-Governor Suazo presented a power point on "Home of Taos Pueblo Students with their Culture and Traditions". The presentation included: The Great Seal of Taos Pueblo-Place of The Red Willows; The Place: Tuah-Tah-The Place that Calls; The People-Tuah-Tah Dainah; Homelands; Government; Tribal Sovereignty; responsibilities, and the future. Governor Suazo also addressed a few items of information and concerns to the board on transportation; safety and disabilities for their students. After some discussion, President Sanborn asked on behalf of the board to please follow up on some of the concerns that were addressed and to report back to the Taos Pueblo and the board with solutions. Dr. Torrez stated that they have presently been working with the Taos Pueblo Vernon Lujan and will continue to address any and all issues. Member Mark Flores also asked how difficult it would be to designate a Taos Pueblo route with possibly a bus just for that area, and have effective bus service for all students in the future.

b) Indian Ed Program Budget-CJ Grace/Susie Martinez

CJ Grace and Rae Lujan presented a power point on Indian Ed Program Budget; NMPED Grant Update; Tribal Education Status Report, and Native Ed (EWS) Early Warning System, all which fall under presentations. Rae Lujan also addressed questions on the power point along with Ms. Grace. Jeanette Vigil; Sharon Salazar, and Amanda Cantu were recognized for their work in the Indian Ed Program, they were not able to attend the meeting.

c) NMPED Grant Update-CJ Grace/Rae Lujan

Power Point Presentation-Professional development for TMS staff to support culturally responsive schools. Reading and Math academic support for students, college visits, cultural workshops & trips, materials to support Native American curriculum.

d) Tribal Education Status Report-CJ

Power Point Presentation-Presented on student enrollment; student achievement; school safety; graduation rate, and attendance. Parent and Community Involvement; policy and procedures, and initiatives to decrease the dropout rate and increase attendance.

e) Native Ed (EWS) Early Warning System Presentation-Rae Lujan, Amanda Cantu, Sharon Salazar, Jeanette Vigil

Power Point Presentation-How we are working to support student attendance and success.
